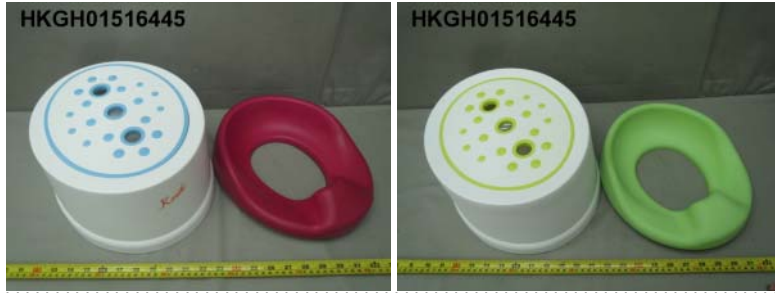

Tests Conducted

1 Loading test for Step stool

Test standard: In-house method per applicant's specification

Test procedure:

1. The submitted step stool was placed on a rigid flat surface.
2. A cylindrical mass of 50 kg with a diameter of 150 mm was placed to the center of the upper surface of the stool for 1 hour.
3. The load was then removed and observation was made for any visible change or damage on the stool.

Number of sample tested : One (1) piece.

Result:

No visible change or damage was observed on the step stool after the test.

2 Slippage test for Step stool

Test standard: In-house method per applicant's specification

Test procedure:

1. The submitted step stool was placed on a wet tile floor surface.
2. Water was splashed onto the top surface of the stool.
3. Assessment was made for any slippage between the stool and floor, as well as the top surface of the stool by stepping on it as intended.

Number of sample tested : One (1) piece.

Result:

No slippage was noted between the stool and floor, as well as the top surface of stool and the foot of the user during the test.
